1. Welcome and Apologies

JR welcomed SW and LB.

2. Minutes of the Last Meeting – November 2022 and April 2023

All content with the last two sets of Minutes. JR suggested an action log would be useful **(ACTION GP – Action log)**.

3. Chair – news and current issues

JR asked about annual report, EF explained its situation, ready to send over to RS – JR asked for it to be published by end of September (ACTION EF – Annual report publishing).

FH highlighted the need for a metal detectorist on the panel. Unfortunately, not in this round but agreed to be encouraged and kept under review.

4. TTU Report – EF

Outreach

EF highlighted upcoming outreach – TTU are attending two rallies over the next two Saturdays (02/09, 09/09), one in Scottish Borders, one in East Lothian. EF highlighted potential difficulties, particularly the use of fields with scheduled monuments – TTU have been liaising with Historic Environment Scotland and Police Scotland. Panel discussed TTU's perception with rally attendees and how Treasure Trove was considered by rally organisers and detectorists coming from outside of Scotland. EF conveyed that TTU presence at the upcoming rallies was just the beginning of engagement and there was more work to be done. LB asked if there is scope for discussing this in the review, MD and SK agreed.

JR asked if it would be possible to get data on the number of known rallies taking place, attendance, and frequency to allow a degree of anticipation (ACTION EF).

MD asked whether people declare that objects were found at a rally, EF said that they sometimes do, but that it is not currently a question on the reporting form. RS said that it would be useful to know the translation rate of objects found at rallies to objects handed in.

Other outreach events coming up includes:

- Inverness, Highland Council HQ finds day. 07/10/2023
- Glasgow, Kelvingrove Art Gallery and Museum finds day. 28/10/2023

JR recommended panel members attend Finds Days.

EF reported that since the last meeting, EF had attended the NPCC meeting at the British Museum, London, and SF had been to Denmark to speak at a conference for metal detecting and networking with other finds recording teams. SF highlighted the difference in resourcing across recording schemes in Europe as well as the finders' attitude, which will be useful to keep in mind for the review. EF reported re-engaging with the Finds Liaison Officers based in Northern England.

TTU also had Finds Days in Dundee, Fife, and a couriering trip in Ayr.

Excavations

EF reported that there have been three excavations since last meeting. JR asked what burden this added to TTU, EF explained that two excavations took one day each, producing little to be dealt with later, while one took three days, producing more finds but with minimal impact on future TTU work.

Heritage Crime

TTU are following up on an artefact being sold online with a Scottish findspot. LB asked how these sorts of cases are usually tracked, EF reported in this instance, Police Scotland had been alerted. JR asked about the possibility of using AI to search and, LB suggested it could be possible (ACTION: LB to chat with EF about possibilities of AI). Panel discussed possible actions to be taken as part of the TT review to improve tracking illegal sales.

EF also outlined a second case which TTU and Police Scotland have been working on – this was flagged to the unit by an auction house. EF commended JF and SF on the large amount of work this has been, and the progress made in the case. RS encouraged EF to work more closely with KLTR for heritage crime.

Backlog

Backlog numbers: 48% of the backlog processed since February, should be completed by March 2024. However, due to the number of artefacts handed in over the same time period, there has been an overall 43% gain.

JR asked that the data be sent prior to the next meeting with EF's commentary

BS asked if TTU uses data management tools, EF explained TTU data management. JR said this was a good point for infrastructure change and financing.

MD asked about deaccessioning of Treasure objects by museums. Several members of the panel explained museum disposal policies.

5. NMS Report

FH explained that, though he is vacating the post of Acting Keeper, he will remain a member of SAFAP at least until a new permanent Keeper is brought on, which was welcomed.

FH also bhighlighted that the temporary TTU posts have been extended by two years and thanked RS.

FH noted that that NMS are bidding for a large number of cases this year due to local museums not applying.

FH elaborated on the three-day NMS/TTU excavation in the Scottish Borders.

6. KLTR Report

RS introduced the Treasure Trove review team, explained that Dr Stuart Allan will be joining them as head of the review on Monday, 04/09.

RS said to expect a consultation paper by Spring of 2024 featuring analysis and recommendations. MD and SK will be staying on for another year beyond the review to oversee implementation, said that there is clearly a need for leadership and joining up, as well as of sponsorship of TT activities.

As of 31/08, KLTR is a fully-fledged Non-Executive Agency, headed by John Logue and supported by RS and team. RS explained that KLTR will seek to fund TTU through earmarked funding, to uncouple TTU from NMS' general finances and bidding processes.

7. **AOCB**

JF reported on her investigation of a Medieval sword which was brought up at the previous meeting. The alleged provenance, if correct, would make the sword nationally significant and whilst the type and condition would be consistent with a sword from Scotland, provenance could not be traced pre-2016. PY, JR, and LB agree with JF. FH suggested contacting the local authority archaeologist in case of local knowledge. **(ACTION JF)**

PY brought up that Archaeology Scotland Winter edition will have a SAFAP/TTU theme, and that they would like two main articles, one from JR and one from EF. Deadline 20/10, publication end of November. **(ACTION EF, JR)**

8. Complicated Cases

JR asked in future for a short briefing of the key issues in complicated cases to assist Panel consideration (ACTION EF).
